According to the Rules and Regulations of the Indiana County Municipal Services Authority, any person(s) defined as a new consumer receiving water services from the Authority must fill out a new customer application and make a proper security deposit. Deposits for service for a period of less than thirty (30) days shall be equal to the estimated gross bill for the temporary period. Deposits from all other customers shall be required with a maximum amount not to exceed the amount of any three (3) billing periods. Deposits will be credited to the depositor's account when they have paid "undisputed" bills for service over a period of twelve (12) consecutive months, or upon discontinuance of service by the consumer and payment of all charges due. No interest will be paid on deposits. All consumers will be subject to the Rates, Rules, and Regulations of the Authority.
